- 1. **Description of agenda item:** The Board is being asked to approve a contract increase with Dr. Ranajit (Ron) Sahu in the amount of \$25,000, as allocated in the FY2026 budget, and authorize the Executive Director to carry out a corresponding change order to increase contract 5057.24.01 by \$25,000 for a new not to exceed amount of \$93,000.00. The additional funds (\$25,000) will be utilized for subject matter expert review and recommendations on addressing potential and actual sources of air quality pollution at the Valdez Marine Terminal (VMT).
- 2. **Why is this item important to PWSRCAC:** This item is important to PWSRCAC to address potential and actual sources of air pollution at the VMT which may pose adverse environmental and health impacts to residents of Prince William Sound.

- 6. **Relationship to LRP and Budget:** Work associated with project 5057 Title V Air Quality Permit Review is included in the FY2026 budget in the total amount of \$60,963. This included committed carryover from FY2025, and \$25,000 of funds available for this contract increase. This project ranked 9 out of 23 in the Board approved Long Range Plan.
