
#### What is a contingency plan?

#### Why are these plans important?

- Binding contract between regulators and operators ("plan holders")
- Provides a plan to protect resources and livelihoods
- Lists the steps to be taken before, during, and after an emergency
- Provides detailed information on prevention and response activities
- Avoid complacency and prevent future spills

Spill Traveled 470 miles


Shoreline Impacts ~1,300 Miles

#### **PWSRCAC's Role in Reviewing Plans**

- Plan review is part of OPA
   90 mandate
- Review plan amendments
- Plan renewals every five years
- Submit comments to approving agencies



#### **PWSRCAC's Review Goals**

- Ensure state and federal regulations are met
- Address concerns
- Verify plan includes prior commitments
- Ensure best technology is used to prevent oil spills
- Verify sufficient equipment and personnel to prevent resource damages and clean up the oil
- Incorporate lessons learned from drills, training, and actual spills


#### PWS Tanker C-Plan 2023 Major Amendment Timeline

Sept 11, 2023	Application for major amendment submitted by shippers
Sept 20, 2023	Start of 30-day public comment period
Oct 20, 2023	Comments and suggested requests for additional information (RFAIs) submitted by PWSRCAC
Dec 6, 2023	ADEC issued 1st set of RFAIs
Jan 19, 2024	Responses to 1st set of RFAIs submitted by shippers
Feb 28, 2024	ADEC issued 2 <sup>nd</sup> set of RFAIs
Apr 4, 2024	Responses to 2 <sup>nd</sup> set of RFAIs submitted by shippers
Apr 8, 2024	Start of final 10-day public comment period
Apr 17, 2024	Final comments submitted by PWSRCAC
Apr 26, 2024	ADEC found application package complete
June 21, 2024	ADEC issued decision on major amendment

- Updated the plan to comply with new regulations
- Updated to Core Plan, Tech Manual, shippers' plans
- New plan language required including:
  - Decanting plans
- Location of fire suppression equipment
- Changes to BAT section
- Removal of PWS tow package
